The Environmental Law LL.M. program offers students the opportunity to deepen their knowledge in environmental law and policy through traditional classroom study, experiential learning opportunities, and one-on-one academic advising. Students are required to take a minimum of 24 credits of coursework, conduct a large research project and complete a clinic, practicum or externship working directly with clients on real environmental disputes.

"It was a delight to work with Ben," says Professor Kim Diana Connolly, vice dean for advocacy and experiential education at University at Buffalo School of Law and who served as his experiential learning supervisor and thesis advisor. "He was able to share what he learned from his first few years of practice which added a lot to the classroom experience for everyone, and enhanced his community work. His thesis entitled Local Legislative Power in New York State: The 'Ghost of Home Rule,' the Specter of Dillon, and the need for Exorcism by Constitutional Convention, was outstanding."
